Went to Vermont College to work on Master's degree in Art Therap, during these years I became assistant backdrop painter for a company called Oliphant Backdrops (main studio in Brooklyn) this is where I learned sky gradations, faux brick walls, color mottling and much more. Then life took another turn, and I ended up co-owning a small restaurant in Vermont.

The restaurant catering event planning business became a part of my life and still is to some degree. In 1999 my brother-in-law sent me to a Martin Alan Hirsch class and I was so excited at what I learned and have for the past 23 years continued down this path of decorative painting. In 2008 began a company called Ruby Rose Studios out of Columbus, Ohio worked closely with designers and in 2011 our company landed a job traveling around to work in the Soft Surroundings retail stores.

In 2010 I began to take the skills of decorative painting, built wood canvases, and began creating wall art and traveling around doing variety of art festivals.

In 2015 I moved to St. Louis for a family restaurant project and left the world of being an artist for 4 years but by 2019 realized restaurant work was not for me. In 2020 scheduled to take a trip to Italy with Gary Lord, but trip got canceled due to Covid. Interestingly I saw another attendee on the list from St. Louis, Beth Warneke. I reached out to her and introduced myself and talked to her about getting back into the business and establishing myself in St. Louis. She amazingly opened her studio up to me to begin recreating a portfolio. And introduced me to MAG our local chapter and of course IDAL.
